

Gujarat Public Service Commission CORRIGENDUM

Advertisement No. 21/2022-23 (Final Result)

Revision in Notification No:- CCE-1306-(3)-2022-EX-1 issued on date 06.07.2024

- 1. The Final result of the Competitive Examination (Main) for the posts of **Accounts Officer, Gujarat Accounts Service, Class-I** (**Advertisement No. 21/2022-23**) written test held on 21st,23rd and 25th August, 2023 and personal interview test held during 1st to 3rd July, 2024 was declared vide Notification annexed with Annexure-I (Part-I, Part-II and Part-III) dt. **06.07.2024**
- 2. Consequent upon receiving the applications for rechecking of marks from the list of successful and unsuccessful candidates listed respectively at Part-I, Part-II and Part-III of the Annexure- I, scrutiny of the answer-books was conducted by the Commission and it is observed that
 - a. in evaluation process of <u>Sub-Question No. 9 of Question No.10</u> of Paper-II pertaining to English Grammar, an error came to the notice of the Commission and same was required to be rectified. Accordingly, the rectification process was conducted by applying the correct answer key. Resultantly, the marks in Paper-II were revised in many cases either by increased with 1 mark or decreased with 1 mark. This has also revised the Final aggregate marks (total marks) of the candidates in the exam, accordingly their merit order stands changed.
 - b. In another case of rechecking of answer-sheet of candidate bearing Roll No. 101002035, it is also observed that due to technical error in reading of the correct answer of the answer-sheet for Paper-II of <u>Sub-Question No. 20 of Question No.10</u> of Paper-II was skipped from evaluation process hence the same was required to be corrected by applying the rectification process and the same is done, thus resulted into addition of 1 marks of that answer-sheet.
- 3. As a result of the above revisions carried out,
 - a. order of merit and qualifying standards (cut-off marks) of the concerned categories stands changed. Therefore, Annexure-I (Part-I, Part-II and Part-III) of the Notification No:-CCE-1306-(3)-2022-EX-1 dt. 06.07.2024 stands revised.

- 4. Now, the qualifying marks for the SEBC(Male) category is 319.50 but the roll number 101001829 gets total mark 319.25 for the main written examination. So he stands disqualified for the interview.
- 5. Revised Annexure-I (Part-I, Part-II and Part-III) is attached herewith.
- 6. The other details except note para-2, 3, 4 and 5 of the above mentioned Notification dated 06.07.2024 remain same.
- 7. The above result shall be subject to the final decision of the Hon'ble High Court in S.C.A. No. 13387 of 2024.
