NOTIFICATION

Whereas, MMSRB has advertised the post of 164 Staff Nurse and 78 ANM vide Advertisement No. HSM/MMSRB/Nursing/12/24/19, dated 30th July, 2024.

Whereas, MMSRB has published the list of all candidates with marks vide Notification No. HSM/MMSRB/Nursing/12/24/166, dated 30/9/2024.

Whereas, a Grievance Redressal Cell was constituted by MMSRB vide Notification No. HSM/MMSRB/Nursing/12/24/165, dated 28/9/2024 to address the concerns raised by the candidates w.e.f. 1st October, 2024 till the 16th October, 2024. The Grievance Redressal Cell received 101 applications during this period. All the Grievances were addressed and cleared by Grievance Redressal Cell in consultation with Law Department and Expert agency.

Whereas, the Expert agency has pointed out the following observations:

- a. There was a typographical error with the Answer Key provided by the expert agency which was uploaded in the website regarding Question No. 21 (set A), 53 (set B), 78 (set C) & 4 (set D).
- b. There was a typographical error with the question No. 42 (set A), 74 (set B), 99 (set C) & 25 (set D) as provided by the expert agency where in place of "Defined" the word "denied" was printed.

Now therefore, in view of the above observations and keeping in line with principles of natural justice, the Board in its effort of ensuring a fair and transparent conduct of the recruitment process, has decided on the following important considerations:

- I. A grace mark of 1 mark was given to all candidates whose answer was shown wrong for point A above during the initial evaluation of OMR Response sheet by the system. However, no mark was given to those who did not attempt at all.
- II. A grace mark of 1 mark was given to all candidates whose answer was shown wrong for point B above during the initial evaluation of OMR Response sheet by the system. However, no mark was given to those who did not attempt at all.

In view of the above and after satisfactory settlement of all grievances, the list has been updated accordingly and uploaded in the website www.meghealth.gov.in.

This process of **DOCUMENT VERIFICATION** will commence from 13th December, 2024 and the candidates will be called in descending order, as per vacancies advertised.

IMPORTANT - PLEASE NOTE:

1. If 2 (two) or more candidates have secured equal percentage of total marks in the qualifying examination, the order of merit in respect of such candidates shall be fixed on the basis of their age (the person or persons older in age being placed higher in the order of merit).
2. If, during the process of physical verification of documents, some documents are found missing or not in order, a window period of 72 (seventy-two) hours will be given to the candidates to correct this discrepancy. No documents will be accepted after the 72 (seventy-two) hours has elapsed.
