(ii) Copy of the debit/credit card statement or Bank account statement as the case may be, in case the fee has been paid through debit/ credit card or through internet banking of authorized banks. The copy of the statement should be duly authenticated by the bank authorities.

4. In case, valid documentary evidence is not received by the prescribed date (15/04/2024), the application will not be considered for revival. No further communication /request will be entertained by the Commission after the date mentioned above.
