- 1. The result of the Competitive Examination (Main) for the posts of **Accounts**Officer, Gujarat Accounts Service, Class-I (Advertisement No. 21/202223) written test held on 21<sup>st</sup>,23<sup>rd</sup> and 25<sup>th</sup> August, 2023 and personal interview test held during 1<sup>st</sup> to 3<sup>rd</sup> July, 2024 is hereby declared as per **Annexure-I**
- 2. The above result is declared taking into consideration the provisions of the Accounts Officer, Class-I Recruitment Rules, 2019, amendments made thereafter from time to time and Accounts Officer, Class-I, in the Gujarat Accounts Service, Competitive Examination Rules, 2020 and amendments made thereafter from time to time and other relevant applicable criteria.
- **3.** As provided in the Rules of the Accounts Officer, Class-I, Competitive Examination Rules, 2020 and amendments made thereafter from time to time,
  - (i) As per Rule-16(1): The merit has been determined on the basis of the **aggregate marks** (total marks) awarded to the candidates in the Main Examination (i.e. 900 marks of written examination + 100 marks of Personality Test).
  - (ii) As per Rule 19: **Waiting List** of 20% of the vacancies advertised for each category is prepared by the Commission.
  - (iii) As per Rule 17: The candidate, who fails to attend the **Personality Test** is not considered as eligible for selection.
- 4. The result of the examination under reference given in the **ANNEXURE-I (Part-1)** has been prepared by strictly applying the ratio laid down by by the following Judgements of the Hon'ble Supreme Court in the cases of
  - (i) Rajesh Kumar Daria V/s. Rajasthan Public Service Commission, Civil Appeal Nos. 3132 of 2007, 3773 of 2007 decided on 18-07-2007.

- (ii) **Public Service Commission, Uttaranchal V/s. Mamta Bist & Others**, Civil Appeal Nos. 5987 of 2007, with Civil Appeal No.5982 of 2007 decided on 03-06-2010.
- 5. The Reserved Category Candidates, who get either equal or more than minimum marks fixed as qualifying standard for general candidates and have not availed of any relaxation in age, qualifying standard etc., at any point of the examination process (Meritorious reserved Category {MRC} Candidates) have been selected against unreserved posts in order of merit as per G.A.D. Circular No. PVS-1099-MM-13-G4, dated 29/01/2000, PVS-2010-03-900-G4, dated 23/07/2004 and PVS-102019-221-G4, dated 07/02/2019.

The following 2 candidates of reserved category (MRC) *are to be recommended for appointment on unreserved posts* 

- 1. The SEBC candidates at Merit Nos. 02, and 04 = Total 02.
- 6. With regard to women reservation as provided for in the G.A.D. Notification No. GS/97-13-CRR/1096/2213/G-2, dated 09/04/1997, G.A.D. Circular No. CRR/1096/ 2213/ G-2, dated 22/05/1997, G.A.D. Notification No. GS/2012/12/CRR/1096/2213/G-2, dated 14/06/2012, GS/2014/37/CRR/1096/2213/G-2 (Part-I), dated 11/11/2014 and GS/2019/16/CRR/1096/2213/G-2 (Part-I), dated 10/06/2019, 04 women candidates (General-02 and SEBC-02) are required to be selected. As against this, 02 women candidates of General Category (i.e. Merit Nos. 03 and 06) and 02 women candidates of SEBC Category (i.e. Merit Nos. 10 and 11) have been selected.
- 7. Accordingly, at Annexure I of this notification,
  - (i) The list of candidates to be recommend to the Government for appointment to the posts of Accounts Officer, Gujarat Accounts Service, Class-I are shown in Part-I
  - (ii) The Candidates to be kept on Waiting List are shown in Part-II and
