

1. Candidates should carry the copy of the Admit Card downloaded from the APPSC website along with the original copy of the ID card which is mentioned in the Admit Card.
2. All candidates should mandatorily go through frisking booth/counter while entering the venue and get their biometric details captured for each session. Therefore, candidates should reach exam centre on time.
3. Prohibited items in the examination venue include mobile phones, Bluetooth devices, electronic gadgets, calculator, pen etc and any other stationaries/ objectionable items. Hence, refrain from carrying them. Candidates are not allowed to carry any items other than Admit Card & ID card.
4. No entry into the examination venue will be permitted after 08:45 AM (forenoon session) and 12:45 PM (afternoon session)
5. Candidates will not be permitted to leave the examination hall before completion of the exam period.

IMPORTANT INSTRUCTIONS FOR FILLING THE OMR RESPONSE SHEET

1. Candidates should read instructions on the question booklet and back page of the OMR Response Sheets carefully before filling up the OMR response sheet.
2. Use Black Ballpoint pen provided inside the examination hall by APPSC for marking OMR Response Sheet. Use of pencil/ Gel pen is strictly prohibited.
3. This OMR answer sheet consists of three copies, the Original copy, Commission's copy and the Candidate's copy. Do not separate or displace them.
4. Mark your response only in the space provided for the purpose in the '**original copy**' only. Response marked elsewhere will not be counted. Do not darken the responses in the Commission's or Candidate's copy separately.
5. Candidates have to answer questions from multiple choice answer a, b, c or d. Select the right answer of each question and darken the correct circle on the OMR sheet. Once darkened changes are not permitted. Use of Eraser, Nail, Blade, White Fluid/Whitener, etc., to smudge, scratch, damage in any manner on the OMR sheet during Examination is strictly prohibited and OMR Sheet shall not be evaluated in such case.
6. If you darken more than one circle in your answer, your answer will be treated as wrong.
7. Rough work must not be done on the OMR Response Sheet and should be done in the rough work space provided in the Question Booklet.
8. The Roll Number and other details should be written and the corresponding circles should be darkened very carefully by the candidate. In no case second OMR sheet will be provided.
9. Do not make any stray marking or write anything irrelevant on any side of the OMR response sheet, including the track portion. Do not tamper with the barcode printed in the OMR response sheet. Remarks other than the answer will be treated as revealing your identity and upon physical verification if such remarks are found, the OMR response sheet will be invalidated and candidature will be cancelled.
10. Your OMR sheet will be evaluated through electronic scanning process. Incomplete or incorrect entries may render your OMR sheet invalid and will not be evaluated.
11. Candidate must hand over the OMR Sheet without separating the copies to the invigilator at the end of examination. Invigilator will hand over the Candidate's Copy after separating it. The candidate can take away the Question Booklet and Candidate's Copy of OMR Sheet with him/her at the end of the exam.
