REVISED RESULT

Haryana Public Service Commission has revised the result declared on 11.03.2024 for the posts of **Post Graduate Teachers (PGTs) in the subject of Political Science for Rest of Haryana Cadre (Advt No. 32/2023) & Mewat Cadre (Advt. No. 48/2023).**

On account of the final disposal of the CWPs bearing No. 25334/2023, 25156/2023 & 25165/2023, result of the 05 number of the posts kept vacant has been finalized. Further, 07 nos. of the posts have been kept vacant on account of the court cases.

In compliance of the directions passed by the Hon'ble Punjab & Haryana High Court in CWP No. 4374/2024 titled as Neeraj Kumar & another vs. State of Haryana & others & clarifications obtained from the School Education Secondary Department, Haryana, the unfilled vacancies of the EWS category have been filled up from the unreserved categories.
