By Demand Draft for Rs. 250/- for General/OBC candidates and (Rs. 50/- in the case of SC /ST candidates) drawn in favour of 'ESIC Fund A/c No.1' payable at SBI Keralapuram Branch.

No application fee in the case of female candidates/PWD. Incomplete application or without prescribed fee/ documents will be rejected. Fee once paid will not be refunded. Successful applicants will be required to execute prescribed contract.

Documents to be produced at the time of interview

- 1.MBBS degree certificate in original
- 2.Degree Certificate (PG Degree/Diploma) in original (Qualification prescribed for the post).

3. Post-Doctoral Certificate- DM/MCH/DNB in concerned Super Speciality.
4. TCMC/ MCI Registration Certificate
5. Matriculation Certificate in support of Date of Birth
6. Experience Certificate in original
7. Caste Certificate in original with a copy
8. Demand Draft (as applicable)

The SC/ST/OBC/EWS Certificates in original produced, should be as applicable for appointments to posts under Govt. of India and should be signed by a Revenue authority not below the rank of Tahsildar and should contain "Non creamy layer" certificate in respect of OBCs.

Candidates applying in PWD category must possess diasability certificate issued by a duly constituted and authorized Medical Board of the State or Central Govt Hospital/ Institutions.

The eligibility for the walk-in-interview with regard to educational qualifications, medical council registration, experience certificate, community certificate etc. will be determined as on date of interview strictly based on the documents submitted by the candidate. In case of selection, candidates are required to execute a security deposit of Rs. 15,000/- which is refundable at the time of successful completion of contract. The selection is purely on contract basis and can be terminated by either party by giving a one month notice to other.

GENERAL INSTRUCTIONS TO CANDIDATES

1. Those who belong to SC/ST/OBC/EWS category should produce valid caste certificate issued by the Tahsildar/ Revenue Divisional Officer. OBC certificate must be as prescribed vide DoPT, Govt of India OM No. 36012/22/93-Estt.(SCT) dated 15.11.1993 which should certify that the candidate do not belong to anyone of the Creamy Layers.
2. PWD Candidates will be considered as per rules and suitability to job.
3. Private practice of any kind will not be allowed.
4. No TA/DA will be admissible for 'Walk in interview'.
5. Vacancies indicated above may change as per actual requirement on the date of interview.
6. The position of reservation is interchangeable among specialities within each category.
7. Canvassing in any form shall result in disqualification.
8. The posts are contractual and the contractual engagement may be terminated/discontinued by either side giving one month prior notice to this effect without assigning any reason.
9. Hostel accommodation/quarters will not be provided.
10. In case of selection, the candidate has to enter into an agreement with Medical Superintendent, ESIC Hospital, Ezhukone, on Non-judicial stamp paper of Rs.200/-. Upon joining, the selected candidate has to submit a security deposit of Rs 15,000/- (Rupees Fifteen thousand only) as Demand draft in favour of 'ESIC Fund Account No.1' payable at SBI, Keralapuram, which is refundable after successful completion of contract and production of 'No dues certificate'
- 11. Candidates who have already completed Senior Residency for 3 years are not eligible for attending the walk-in-interview for Senior Resident 3 yr.**

GENERAL TERMS AND CONDITIONS APPLICABLE TO FULL TIME CONTRACTUAL SUPER SPECIALISTS:

1. Specialist shall be recruited for a period of 3 years with annual evaluation and term renewed every year based on satisfactory performance.
2. Private practice will not be allowed
3. Available on call 24x 7.
4. The specialist shall be responsible for all cases undergoing treatment under his/her supervision in his/her discipline.
5. The selected specialist must have a professional indemnity policy which should cover the period as desired by ESIC. The policy is meant to cover professional liability falling on them as a result of errors and omissions committed by them while rendering professional services. The minimum sum assured per annum should be Rs.30 lakhs for Anaesthesiologists, Cardiac Surgeon, Neuro Surgeons, Plastic Surgeons etc. (2) Rs.20 lakhs for General Surgeons, Gynaecologist, Obstetrician etc. (3) Rs.10 lakhs for Physicians Dentists, Radiologists, Pathologists etc. A copy of the Insurance & Premium receipt must be submitted within 7 days from the date of engagement.

1. Period of contract will be one year from the date of joining.

5. The specialist shall be responsible for all cases undergoing treatment under his supervision in his discipline.
