CONTRACTUAL/DEPUTATION BASIS UNDER DEPT. OF HEALTH & FAMILY
WELFARE, GOVERNMENT OF ODISHA**

In accordance to Notification No.HFW-MEI-SR-0002-2018-1532/H Dated 19/01/2024 and to meet the NMC guidelines as well as patient care, eligible candidates will be engaged in the Posts of **Professor/Asst. Professor, Senior Residents & Tutors at MJKMCH, Jajpur on contractual /deputation basis through Walk-in-Interview on 12.03.2025 in the Office of Dean & Principal, MJKMCH, Jajpur, Odisha.** The details of Eligibility Criteria/Vacancies etc. are as under. The **Direct** candidates shall be appointed on **Contractual Basis** and the **In-Service** candidates shall be appointed on **Deputation Basis** after due permission of Govt. of Odisha, H&FW Dept. The candidates who are continuing as faculties in any of the Govt. Medical College of the State, VIMSAR, Burla or AHRCC Cuttack, either on contractual/deputation basis are eligible to apply for the **next higher post only**. The **Regular Faculties** of any Govt. Medical College of the state, VIMSAR, Burla or AHRCC Cuttack are **not eligible** to apply. The faculties whose tenure is **terminated** for any adverse reason by the appointing authority will be **debarred** from being selected for a period of next three years.

I. ELIGIBILITY QUALIFICATION:

The candidate must be a citizen of India.

A. PROFESSOR:

Academic Qualifications:

1. Must have possessed MD/MS/DNB/MDS/DM/MCh or equivalent degree in the concerned specialty/ discipline from any NMC/MCI permitted/approved/recognized Medical College as prescribed by NMC.
2. Must have valid up-to-date medical registration along with registration of additional qualification under any State Council of Medical Registration after obtaining the degree.

Teaching and Research Experience:

1. Must have teaching experience of minimum 3years as Associate Professor in the concerned discipline in any MCI/ NMC approved/ recognized/ permitted Medical College.
2. Must have at-least 8years of post-PG experience
3. At least 4 (four) Research Publications (at least 2 as Associate Professor) as per NMC's 'Teachers Eligibility Qualifications in Medical Institutions, 2022'.
4. Must have completed 'Basic Course in Medical Education' from institution designated by NMC.
5. Must have completed Basic Course in Bio-Medical Research.
6. The above qualifications must have been obtained before the date of Walk-In-Interview.

B. ASSOCIATE PROFESSOR:**Academic Qualifications:**

1. Must have possessed MD/MS/DNB/MDS/DM/MCh or equivalent degree in the concerned specialty/ discipline from any NMC/MCI permitted/approved/recognized Medical College as prescribed by NMC.
2. Must have valid up-to-date medical registration along with registration of additional qualification under any State Council of Medical Registration after obtaining the degree.

Teaching and Research Experience:

1. Must have teaching experience of minimum 4years as Assistant Professor in the concerned discipline in any MCI/ NMC approved/ recognized/ permitted Medical College.
2. Must have at-least 5 year post-PG experience.
3. At least 2 Research Publications as per NMC Teachers Eligibility Qualification in Medical Institutions, 2022.
4. Must have completed 'Basic Course in Medical Education' from institution designated by NMC.
5. Must have completed Basic Course in Bio-Medical Research.
6. The above qualifications must have been obtained before the date of Walk-In-Interview.

C. ASSISTANT PROFESSOR:**Academic Qualification:**

1. The candidate must possess MD/MS/DNB/MDS/DM/MCh or equivalent degree in the concerned discipline from any MCI/NMC approved/recognized/permitted Medical Colleges as prescribed by NMC.
2. Must have registered himself/herself under any State Medical Council /MCI/NMC after obtaining the degree.
3. In case of non-availability of such candidates, **Medical M.Sc. qualification with Ph.D** on regular on campus course in Anatomy, Physiology & Biochemistry maybe considered as per NMC, UGMEB Notification No. U.11022/3/2023-UGMEB dated 16/08/2023 [SCHEDULE II- STAFF' REQUIREMENTS- A. General Remarks. 4. In department of Anatomy, Physiology, Biochemistry, non-medical teachers may be appointed to the extent of 15% of the total number of posts in the department subject to non-availability of medical teachers.]

Teaching and Research Experience:

1. Must have completed at least one year of Senior Residency in the concerned subject in a recognized/permitted medical college after acquiring MD/MS/DNB degree.
2. The above qualifications must have been obtained before the date of Walk-In- Interview.

. SENIOR RESIDENT(Medical Post graduates):

Academic qualification:

1. The candidate must possess MD/MS/DNB/MDS/DM/MCh or any Equivalent Degree in concerned discipline applied for as prescribed by MCI/NMC in 'Minimum Qualifications for Teachers in Medical Institutions Regulations,2022' notified or amended from time to time in force. (NB: The MDS qualification is required for SR in Dental stream).
2. The candidate must not be continuing or have completed the tenure as Senior Resident in any MCI/NMC/DCI permitted/approved/recognized Institute.
3. The candidate whose service as Senior Resident has been terminated by any Govt. Medical College in the state for what so ever reason will not be considered for re-engagement.
4. The above qualifications must have been obtained before the date of Walk-In-Interview.
5. Other conditions for engagement of Senior Resident:
 - a. The engagement shall be purely temporary for a period of one year.
 - b. The posts are non-practicing.
 - c. The appointment shall be made as per the terms & conditions/Job responsibilities envisaged in Government Resolution No.18582/ H &FWdt.13.08.2020.

E. Eligibility and qualification for Tutors:

1. For the post of Tutors as prescribed by NMC in Minimum Qualification for Teachers in Medical Institutions Regulations, 2022" from time to time in force.
2. All Qualification as on the date of counseling shall be considered.
3. Other eligibility conditions:
 - a. The candidate must be a citizen of India.
 - b. The candidate must not be continuing as Tutor in any Govt. Medical College of the State.
 - c. The candidate whose service as Tutor has been terminated by any Govt. Medical College in the state for whatsoever reason will not be considered for re-engagement.

II. AGE LIMIT

1. **For Faculties (Professor, Associate Professor and Asst. Professor):** The upper age limit for candidates on contractual basis shall be less than 69 years as on date of interview (The maximum age upto which one can serve is 70 years).
2. **For Senior Residents and Tutor:** The upper age limit must be less than 45 years as on the date of joining of the candidate in the institution in the post for SR/Tutor.

N.B: The date of birth entered in the High School Certificate or equivalent certificate issued by the concerned Board/Council only shall be accepted.

III. SALARY/CONSOLIDATED PAY

1. Salary/consolidated pay of contractual Professors/Associate Professors/Assistant Professors/SR shall be as per the guidelines of Health & FW Department of Govt. of Odisha in place from time to time.
2. The In-Service Candidates shall be allowed salary at par to the post in which appointed and will be eligible to receive any incentive as may be notified by Govt. It will be guided as per the Govt. letter No.9684/HDt.02.05.2022.
3. Any additional incentive declared by the Government of Odisha for these posts shall also be applicable.

IV. ENGAGEMENT PERIOD

1. For contractual direct candidates of Faculty rank (Professor, Associate Professor & Assistant Professor) the engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum four years subject to satisfactory performance.

For contractual direct candidates (Senior Resident and Tutors) the engagement shall be purely temporary and on year-to-year tenure basis and may be for a period of maximum three years subject to requirement and satisfactory performance.

3. However, the Govt. reserves the right to terminate the services of the Faculty/SR/Tutor with one-month prior notice from either side.

V. AVAILABLE VACANCY

The vacancy is **provisional** and is subject to change as on the date of Interview. Vacancies occurring after the date of interview shall be filled up through fresh advertisement. The **Provisional Vacancy Position** is mentioned in **Annexure I** of this Advertisement.

The filling of the google form is a pre-registration process to participate in the Walk-in-Interview. **Without pre-registration the candidates will not be allowed to participate in Walk-in-Interview.** Eligible candidates shall appear personally in the walk-in-interview as per schedule and submit the hard copy application form attached to this advertisement duly filled in an done set of self-attested photocopy of required documents and a color passport photograph. They must bring the original documents for verification. A recruitment fee of Rs. 500/- for each application is to be deposited online in IDBI Bank Ltd., through the Link or QR Code created in the account of Dean & Principal, JKMCH, Jajpur. Professor & Associate Professor

1. Selection will be strictly on the basis of merit list prepared on basis of teaching experience, research publication and age of the candidate.
 - a. Weight age for Teaching Experience: 5 marks per year of experience as Asst. Professor/Associate Professor from MCI/NMC/permitted or recognized institutions.
 - b. Weight age for Research Publications (wherever applicable): 5 marks per publication. (Publications should meet the MCI/NMC criteria prevailing at the time of publication).
2. In case of tie, it will be resolved by seniority in age. The elderly candidates shall be placed higher in rank to the younger.
3. The Merit List will be prepared and sent to the DMET for approval prior to the issue of appointment orders.

5. Engagement will be on the basis of merit. The Direct Candidates must report before the authority of the institution within seven days of issue of engagement order and the In-Service Candidates shall join after obtaining the relieve order from Government.

B. Assistant Professor

The selection for Assistant Professor shall be as under:

1. Selection will be strictly on the basis of merit list prepared on basis of career marks.
2. Weight age for different examinations shall be as under:
 - a. HSC/Matriculation-20% of total percentage of marks secured.
 - b. Intermediate Science-20% of total percentage of marks secured.
 - c. MBBS/M.Sc. examination- 60% of total percentage of marks secured. (In case the candidate has passed PG in 2016-2017 and afterwards MBBS-30% & PG-30%)
3. One mark will be deducted from the total Career Mark for each extra attempt taken top as the examinations.
4. In case of foreign medical graduates (FMG) the marks secured in the subjects as per the NMC/MCI test conducted by NBE shall be taken for calculation of merit as above. Where the candidate does not submit such marksheet, their marks will be taken as 50%.
5. In case of tie, it will be resolved as follows: The candidate securing more mark in MBBS/M.Sc. shall be placed in higher rank. In case of further tie, the elderly candidates shall be placed higher in rank to the younger.
6. The Merit List will be prepared and sent to the DMET for approval and necessary action at our end.
7. All communications shall be made through the official e-mail of JKMCH, Jajpur. (deangmchjajpur@gmail.com)
8. Engagement will be on the basis of merit. The direct candidates must report before the authority of the institution within seven days of issue of engagement order or as may be instructed in the appointment order and the In-Service Candidates shall join after obtaining the relieve order from Government.

C. Senior Residents (Medical Postgraduates) & Tutors.

The selection for Senior resident/Tutor shall be as under:

1. Selection will be strictly on the basis of merit list prepared on basis of career marks.
2. Weight age for different examinations shall be as under:
 - a. HSC/Matriculation-20% of total percentage of marks secured.
 - b. Intermediate Science-20% of total percentage of marks secured.
 - c. MBBS/BDS/M.Sc examination- 60% of total percentage of marks secured.
3. One mark will be deducted from the total Career Mark for each extra attempt taken to pass the examinations.

In case of foreign medical graduates(FMG)the marks secured in the subjects as per the NMC/MCI conducted by NBE shall be taken for calculation of merit as above. Where the candidate doesnot submitsuchmarksheet,their marks will be taken as50%.

5. In case of tie,it will be resolved as follows: The candidate securing more mark in MBBS shall be placed in higher rank. In case of further tie the elderly, candidates shall be placed higher in rank to the younger.
6. The Merit List will be prepared and sent to the DMET for approval and necessary action at our end.

8. Engagement will be on the basis of merit. 
